Dev & Eng Services – Priorities

- Flood Remediation Work (new projects Black Creek Rockcliffe, Dixie Dundas, Bolton Berm, Pickering Ajax)
- Optimizing our development and infrastructure review services with Municipalities. Clarifying expectations consistent across CAs (eg. Updated Procedural Manual, Checklists, Guidelines).
- Training internal and external (TRCA requirements, customer service)
- Enhance pre consultation including introducing pre-submission design charrettes.
- Improving service delivery on development and infrastructure review including implementing streamlining initiatives and proactive watershed planning to assist in development planning.



Dev & Eng Services – Challenges

- Numerous legislation changes eg. CA Act, CA Regulation, Planning Act, Growth Plan, PPS. – Implications on staffing, fee collection.
- LPAT Hearings (ie Vaughan and King), trying to resolve in a timely way.
- Challenging Development files:

 - Caledon Employment Lands development pressure is on
 - Bramalea City Centre, CAA Lands
 - Jane and 401 Floodplain
 Leon's Lands
 - Flemingdon Golf Course
 potential developer purchase
 - Kirby Road Extension-Vaughan
- Staff retention and recruitment.
