Policy Planning – Challenges

More Homes, More Choice Act, Bill 108


First Reading May 2, Amends several Acts, some with their own current ERO proposals with competing deadlines, including:

- Endangered Species Act (May 18)
- CA Act and Permitting Regulation (May 20/21)
- Environmental Assessment Act (May 25)
- Planning Act, Local Planning Appeal Tribunal Act (June 1)

Excess soil regulatory proposal (May 31)

A Place to Grow: Growth Plan for the Greater Golden Horseshoe – effective May 16, 2019 – transition regulation (June 1)

Keeping TRCA Board of Directors informed of above legislative changes
